For donations of items or gift certificates valued at \$25 or above, charitable tax receipts can only be issued in accordance with Canada Revenue Agency (CRA) regulations and upon receipt of all required documentation, such as a sales receipt or appraisal. If you wish to receive a charitable tax receipt for your donation, please complete this donation form.

Big Sisters of BC Lower Mainland may issue a tax receipt for the following donated auction items:

Tangible, Material Goods

Big Sisters of BC Lower Mainland may issue a tax receipt for the market value of a donation of tangible, material goods. E.G. ABC Electronics donates an iPad to the GrapeJuice auction.

Gift Certificates that are NOT donated by the Issuer

Big Sisters of BC Lower Mainland may issue a tax receipt for the donation of a gift certificate when the donor has purchased the gift certificate and then donated it. E.g. An individual purchases an ABC Electronics gift certificate and then donates it to the GrapeJuice Auction.(i.e. The donor is not also the issuer)

Documentation required from the Donor if a tax receipt is requested:

All gift-in-kind items

The donor must supply proof of the current fair market value of the purchased/donated item by providing an itemized invoice, or sales receipt, or copy of a catalogue page or advertisement clearly showing the current fair market value of the donated item. If proof of current fair market value is not available, Big Sisters of BC Lower Mainland requires an appraisal. For items worth \$1,000 or more, an appraisal from a qualified independent appraiser is required. In order to be eligible for a tax receipt, the item purchased must be new, and must be in original wrapping and/or have all sales tags attached. Some exceptions may be made for items such as wine, artwork and jewelry.

Art, antiques, jewelry or rare and unusual collectibles

The donor must supply proof of the current fair market value of the donated item by providing an appraisal of the donated item. The appraisal must be done by a third-party appraiser who is qualified to appraise the donated item. The appraisal must be an original document on the appraiser's official letterhead and show the appraiser's name, address and qualifications.

Big Sisters of BC Lower Mainland cannot issue tax receipts for the following donated auction items:

Donation of Services

Big Sisters of BC Lower Mainland cannot issue tax receipts for donated services (time, skills or effort) because services are not considered to be tangible property. Examples of other services include hotel accommodation, event set-up, entertainment, air miles, loaned vacation property, desk top services or moving services.

Gift Certificates Donated by the Issuer

Big Sisters of BC Lower Mainland cannot issue a tax receipt for a donation of a gift certificate if the donor is also the issuer. (E.g. ABC Electronics donates an ABC Electronics Gift Certificate to the GrapeJuice Auction).
